THE WATCHERS AND THE SONS OF THE GODS

And, as there is the wavering of those that would enter as emissaries, as teachers, from the throne of life, the throne of light, the throne of immortality, and wage war in the air with those of darkness, then know ye the Armageddon is at hand.

A War in Heaven is the dominant theme of so many ancient writings that it presents itself as the cornerstone event in human history. The most notable versions of this war arise out of the Hebraic, Akkadian, Vedic, and Greek civilizations.

In the Hebraic texts, Michael leads the archangels in a war against a rebelling group of two hundred angels, whom I have identified in the previous chapter as the Watchers. The identity of the Watchers remains dubious. Descriptively, they are portrayed in both physical and spiritual terms throughout all Judeo-Christian literature, and this must have been the dilemma for the Fathers of the Church, as well as being a continuing point of contention to this very day.

In his book, *From the Ashes of Angels*, author Andrew Collins theorizes that the Watchers were survivors of a civilization that migrated from the Upper Nile in Egypt

after a global catastrophe sometime after 10,500 BCE. They finally found refuge on the southern coast of Lake Van in eastern Turkey around 9000 BCE. He speculates that some of their descendants eventually left the mountains and settled on the fertile plains between the Tigris and Euphrates Rivers to merge into the history of the Ubaidians and the Sumerians.¹

Interestingly, geneticists have found that there is very little variation in human Deoxyribonucleic Acid or DNA. This lack of genetic diversity seems to be the result of a massive reduction of the human population between 70,000 and 140,000 years ago. An analysis of microsatellite markers in DNA from around the world by researchers at Stanford University and the Russian Academy of Sciences has found that the human population may have dwindled to as low as two thousand people.² The Mbuti pygmies and Khosian Bushmen of sub-Saharan Africa are the closest genetic link to the Paleolithic survivors who may have saved humanity from extinction. A previous study of Y-chromosomes revealed that human migration from Africa seems to have occurred 66,000 years ago.

There is a growing amount of evidence that suggests mass extinctions may be a part of evolution. Global destruction has come from asteroids, super-volcanoes, and possibly from extreme cycles in solar activity. The universe is a dynamic environment, but planetary destruction can also come from a war waged with advanced weapons. Unfortunately, the slightest suggestion of a high human civilization prior to 4000 BCE will guarantee academic wrath; regardless, this is where all the literary and archeological evidence leads.

With universal mathematical constants built into megalithic ruins found across the planet, the evidence for an advanced civilization existing in Earth's past has always been present just intellectually unpalatable. Physical evidence presents itself as it is; it does not conform to theory or academic and religious dogma. Having grown up with the centuries old myths of Atlantis and Lemuria, I find it exciting and remarkable to live in a time when new controversies about ancient civilizations have now appeared as we have begun to explore the planets of our Solar System.

The Face on Mars has been hotly debated issue for over three decades. Photographed on July 20th, 1976 by the United States' Viking One mission to Mars, this severely eroded surface feature at first appeared to be a humanoid face with an Egyptian-like nemes headdress. But questions and controversy still abound, for the subsequent robotic missions to Mars over these last thirty-two years have still not decisively answered whether the Face is a natural part of the terrain, or whether it is a monument carved out of a mesa on the Martian plain known as Cydonia. The main reasons that the debate still continues are that large-scale geological processes do not display such symmetry, and after millions of years of exposure to the hurricane-like Martian dust storms, the ruins of any civilization would have certainly blended into the landscape.

Supporting the artificial origins of the Face, there are nearby pyramid-like structures that resemble a small city. These objects are positioned in such a manner that important trigonometric constants appear in their angular relationships to the Face and with each other. Scientists have yet to adequately address or explain these strange coincidences. And as you will see in the pictures below, there are many more strange features found across Mars that are kindred to lost civilizations found here on Earth.

It seems that as humanity explores the Solar System, it is blasphemous to even suggest that some intelligent beings may have traveled to the planets long before mankind. This is really a public fraud and a diversion, and it is the disinformation specialists paraded before the mass media that keep running interference. Space exploration requires scientists with minds open to whatever possibilities the universe presents, and my guess is that ever since July 7th, 1947, the United States government has been hiring some of the best and giving them very high security clearances. For as you will read in Part Two of this first book, there seems to be a small group of people who have known all along about the secrets waiting on the Moon and Mars; they knew well before the first rocket ever flew into space.

Over the course of these last thirty-two years the mysteries concerning Mars have only grown deeper: from the numerous lost space probes that have never made it to the Red Planet, to the breathtaking and unexplainable photographs that have now been transmitted back to Earth by a small fleet of spacecraft. Two decades after the Viking missions and a series of strange failures for both American and Russian spacecraft, Mars Pathfinder was the first to survive its seven month journey to Mars and land in Ares Vallis on July 4th, 1997. Mars Global Surveyor soon followed; surviving an eleven month voyage, it entered orbit significantly enough on September 11th, 1997. It was the first spacecraft to reimage the Face. Just over six years later, on December 25th, 2003, the European Space Agency successfully guided its first robotic probe, the Mars Express, into orbit.

Please note that all of the above dates, including the date that the picture of the Face was originally taken, July 20th 1976 (the 7th anniversary of the first moonwalk), have ritual and religious significance. This important fact was discovered by Richard Hoagland after his analysis of many notable dates in the history of the American space program. His theory is freely presented on his website.³ In Part Two of this book it becomes an important link in identifying Nostradamus' "Pagan Sect".

Even though it appears that many of the pictures from Mars have been altered, the evidence of eroding structures, vegetation, and flowing water is so overwhelming that to alter the photographs anymore would raise suspicion. In fact, on December 8th, 2006, NASA finally admitted that there was sufficient evidence to accept that water had recently flowed on Mars. Unbelievably, the media, the academic world, and government officials still treat all of these amazing pictures with stony silence. The mere suggestions



But as it can be seen from these photographs of Mars taken from the Viking One Mission and the Mars Rover, Spirit, the skies above Mars are not unlike those of Earth. At the Jet Propulsion Laboratory press conference on January 10th, 2004 after the successful landing and deployment of the Rover, the public seems to have been given a true glimpse of the surface of Mars. What is the motive for tampering with some photographs while openly displaying contradictory images?

It is beyond coincidence that photographs of pyramid cities on Mars should resemble the ancient pyramids and ziggurats found all over the Earth. There is powerful evidence that a magnificent civilization may have extended across the Solar System, yet only a few brave academic souls have challenged the mainstream view of history. I suggest to you that this is the Grail of all secrets. It is the gateway to our past and to our future. Perhaps it even suggests why the National Aeronautic and Space Association named a space shuttle, Atlantis.

From his analysis of the Solar System and particularly the asteroid belt, Dr. Tom Van Flandern, formally the Chief of the Celestial Mechanics Branch at the Naval Observatory has hypothesized that Mars was once the moon of a planet that exploded millions of years ago. Dr. Van Flandern and his associates have also uncovered startling photographic evidence of ancient ruins all across Mars, while still other researchers now believe that there may be ruins on the moons of Jupiter and Saturn. This would seem to indicate that a very advanced civilization had flourished eons in the past. It was a civilization that carved its memories into the planets and moons of the Solar System so that they could never be lost to time.

It is not coincidental that the present-day controversy over an ancient Martian civilization follows a long string of historical oddities concerning the Red Planet. It begins well before July 1976. Both Nikola Tesla, the pioneer of alternating current, and Guglielmo Marconi, the first developer of radio, reported receiving signals that they thought originated from Mars.

In the 1966 bestseller, *Flying Saucers – Serious Business*, Frank Edwards wrote that on August 23rd, 1924 the United States Navy wanted to signal Mars with Charles Francis Jenkins' new invention called the Radio-Camera.

Doctor David Todd, Professor of Astronomy at Amherst College, conducted the test at the Naval Observatory. During the twenty-nine hour period of Mars closest approach to Earth the dots and dashes received from the fourth planet were recorded on film. The New York Times of August 28, 1924 reported that after examining the clusters of dots and dashes, also received by separate operators across the globe, "...the shape of a crudely drawn human face" appeared in each cluster.⁶

The New York Times' article and Frank Edwards' book predate the current controversy over the Face on Mars by a respectable margin. The fact that this book sat on my shelf for a decade before either of the Viking spacecraft traveled to Mars presents sufficient evidence that there is more at work here than mere coincidence.

As mocked as the ancient astronaut theory has been over the last generation, mainstream concepts of history are beginning to crumble. Geologists are now challenging historians, archeologists, and Egyptologists by suggesting that the Sphinx has endured over twelve thousand years of Egypt's weather. This date clashes with the academically accepted age of civilization as between six and seven thousand years old, and the Sphinx's accepted age of four thousand years.

A high civilization once existed on Earth, and the physical evidence is overwhelming, yet even facts of physics are held in disdain by mainstream academia. Ancient monuments erected on many continents exceed the engineering capabilities of today.







The center inclination of the Great Pyramid is only seen at certain angles.

























What appears to be a dome sits inside a Martian crater. Notice the hint of a geodesic rib structure outlined in the sand covering the dome.











Arthur C. Clarke November 15th, 2005, Sri Lanka "I'm now quite convinced that Mars is infested with life. Mars Orbiter photographs show huge areas of vegetation. I don't think there's any doubt anymore on that. And where there's vegetation, they'll be something nibbling on it."

As Richard C. Hoagland points out, human circadian rhythms are 24.9 hours, the exact length of a Martian day. Author of *The Monuments of Mars*, this science writer and former NASA consultant proposes that humanity may have originally come from Mars. From investigating why so many American and Russian robotic craft apparently never make it to the planet, to questioning why a sole private contractor is placed in charge of publicly owned telemetric and photographic data, he and his organization, *The Enterprise Mission*, have continually challenged the bureaucratic secrecy surrounding all exploratory missions to Mars and the Moon. At the same time he has discovered some very strange behavior from government officials that is surprisingly well documented and crucial to understanding the religious aspects of the Martian mystery, for it is tied directly to the apocalypse.

The 2003 Pentagon Environmental Report predicts future wars will erupt over dwindling natural resources. Can it also be possible that after a global catastrophe in our past, survivors ended up in a violent struggle to stay alive? The first generation of survivors would have been the most technically advanced. Ultimately, they would have had to

use what remaining technology they had to secure the last of the available resources and arable land. World myths seem to indicate that the gods unleashed some very destructive weapons in their struggle to stay alive.

The extent of this ancient war and its ramifications to our future are the primary questions this first book will explore. Since it is clear that this culture had the capability of space flight, one must ask, was this an interplanetary war or an interstellar war? An interplanetary war would mean that the war is probably over and humanity is a surviving remnant of a once great civilization that never made it out of the Solar System. An interstellar war could mean that there is a possibility that the war continues to this very day.

Both prophecy and religious mythemes indicate that the war is ongoing.

The only place we can begin to look for answers to these questions is in what is left to us of the historical record – that is the oldest literary accounts of all cultures, regardless and oblivious to all mythological and theological connotations.

The Hebraic texts give us a detailed account of when human beings first became self-aware. In the *Old Testament* the serpent tempted Eve to eat of the tree of knowledge of good and evil; the serpent was also a Watcher. The *Book of Enoch* provides the greatest amount of detail about how the Watchers awakened humanity. Going back to the Greek codices, the term egregoris or grigori is taken from the Aramaic transliteration *'iyrin*. The singular root, *'iyr*, means to watch, awake, or rouse.

In the *Old Testament* this masculine noun is found exclusively in the book of *Daniel*. The remaining biblical references are the proper names of locations that refer to the Watchers using the word Zophim, which first appears in *Numbers* 23:14, when Balak and Balaam go to the "*Field of Zophim*" or the "*Field of Watchers*." It is the site of Balaam's oracles atop Mt. Pisgah in Jordan and the very same mountain from which Yahweh showed Moses the land of Canaan.

In 1 Samuel 1:1, El-ka-nah was from Ramathaim-zophim, which literally means "double height of the watchers." It is believed to reference the hill country of Ephraim. The main city, Samaria, was once the ancient capital of Israel's northern kingdom. It is an interesting correlation that the Ephraimites were the most warlike of Israel's twelve tribes. The children of the Watchers were supposedly destroyed because of their appetite for war.

The *Book of Jubilees*, found with the *Dead Sea Scrolls* and sometimes called the *Apocalypse of Moses*, the *Testament of Moses*, or the *Lesser Genesis*, tells us that the Watchers first descended to Earth when Enoch's father was born.

Book of Jubilees 4:15 (R.H. Charles)

Mahalalel took unto him Dinah ... and she bare him a son ... and he called him Jared, for in his days the angels of the Lord descended on the earth,

those who are named the Watchers, that they should instruct the children of men, and that they should do judgment and uprightness on the earth.

This verse certainly implies that the Watchers were physical and visiting for the first time. The text therefore suggests that the Watchers were welcomed and directed to be teachers, or at the very least models of civility. However, all other references about them imparting knowledge to humanity consider this their greatest crime. The second gravest charge against them was, of course, lusting after the daughters of men and then taking them for wives.

Book of Enoch VII:1 (Richard Laurence Translation)

It happened that the sons of men had multiplied in those days, that daughters were born to them, elegant and beautiful.

Book of Enoch VII:2 (Richard Laurence Translation)

And when the angels, the sons of heaven, beheld them, they became enamoured of them, saying to each other, Come, let us select for ourselves wives from the progeny of men, and let us beget children.

Book of Enoch VIII:2 (Richard Laurence Translation)

Impiety increased; fornication multiplied; and they transgressed and corrupted all their ways.

The *Book of Enoch* makes it clear that descending to Earth violated a great law instituted by the Holy Ones of Heaven. Intending to disobey this law, two hundred Watchers swear an oath together to suffer the same punishment should they be caught leaving their station to descend to Earth. It is the first recorded mutiny in history. Perhaps the reason Fletcher Christian and the other mutineers of the H.M.S. Bounty have made their way into legend is because their rebellion is a reminder of our ancient past.

Book of Enoch VII:3 (Richard Laurence Translation)

Then their leader Samyaza said to them; I fear that you may perhaps be indisposed to the performance of this enterprise;

Book of Enoch VII:4 (Richard Laurence Translation)

And that I alone shall suffer for so grievous a crime.

Book of Enoch VII:5 (Richard Laurence Translation)

But they answered him and said; We all swear;

Book of Enoch VII:6 (Richard Laurence Translation)

And bind ourselves by mutual execrations ...

Book of Enoch VIII:7 (Richard Laurence Translation)

Then they all swore together, and all bound themselves by mutual execrations. Their whole number was two hundred, who descended upon Ardis, which is the top of mount Armon. (Mt. Hermon, Syria)

Today this part of the Golan Heights is bitterly contested territory. Hermon comes from the Hebrew word herem, or curse. One side of Mt. Hermon is occupied by Syrian troops and the other side is occupied by Israeli troops. It is interesting to note that the lands most embroiled in conflict today have a legacy of warfare that reaches far back into history, and that certainly includes the current war in Iraq, the ancient home of the gods.

Mt. Hermon, Syria is where the Fallen Angels first descended.

The first fact to set straight, which has been pointed out by numerous scholars and researchers, is that both *Genesis* 6:2 and 6:4 have been translated incorrectly for centuries. "*The sons of God*" is translated from "bene ha-elohim." Elohim is the plural of God and so should properly be read as, "the sons of the Gods."

Genesis 6:2 (King James)

That the sons of God saw the daughters of men that they were fair, and they took them wives of all which they chose.

Genesis 6:4 (Jewish Publication Society 1917)

The Nephilim were in the earth in those days, and also after that, when the sons of G-d came in unto the daughters of men, and they bore children to them; the same were the mighty men that were of old, the men of renown.

Another point of debate in scholarly, theological, and metaphysical circles centers around the Hebrew word Nephilim whose root is nephil and which the Greeks translated as gigantes or giants. Its root can also mean causing to fall or violent. Tying *Genesis* 6:4 in with the *Book of Enoch* and with one of the *Dead Sea Scrolls* known as the *Book of the Giants*, I take the same view as the majority of commentators that the Nephilim were the

progeny of the Watchers and their human spouses. It is likely that the mutinous Watchers were one of three groups the *Old Testament* generically labeled the "sons of the Gods." Therefore, I accept that the Nephilim were the demigod heroes and villains recorded in the mythologies of many lands. All references to them in this book are defined from that point-of-view.

Book of Enoch VII:11 (Richard Laurence Translation)

And the women conceiving brought forth giants,

Whose stature was each three hundred cubits.

Numbers 13:33 (Translation Jewish Publication Society)

And there we saw the Nephilim, the sons of Anak, who come of the Nephilim; and we were in our own sight as grasshoppers, and so we were in their sight.

In Hebron there were till then left the race of giants, who had bodies so large, and countenances so entirely different from other men, that they were surprising to the sight, and terrible to the hearing.

Deuteronomy 3:11 (King James)

For only Og king of Bashan remained of the remnant of giants; behold his bedstead was a bedstead of iron; is it not in Rabbath of the children of Ammon? nine cubits was the length thereof, and four cubits the breadth of it, after the cubit of a man.

In the *Book of Enoch* the exact height of the Nephilim is given as three hundred cubits. The cubit is thought to have appeared between 2800 BCE and 2300 BCE and varies from culture to culture. It is generally accepted as being from seventeen inches to twenty-two inches in length. According to the *Book of Enoch* this would make the Nephilim anywhere from four hundred and twenty-five feet to five hundred and fifty feet tall, a seemingly impossible size considering their Earthly parentage. Yet remember the term *Ramathaim-zophim*, or "double height of the watchers," and the reference to the hill country of Ephraim where the terrain suggests that there may be a correlation with this extreme height. If it sounds too incredible, hold on to your disbelief. As you will read further on in this chapter, I suggest that this great size is a reference to the war machines of the Nephilim.

In the *Old Testament*, at its largest, the bed for King Og was over sixteen feet long, which makes it palatably less extraordinary. The multi-faceted nature of the Hebrew language and passages from extracanonical texts suggest that the "mighty men" may also have been associated with some mode of aerial transportation. In Chapter Five, you will

read that in Hindu religious scriptures, the gods and demons fought with aerial machines the size of cities.

If you are constrained by orthodoxy, then there are no other resources to fall back on when trying to make sense out of the descriptions of the world found in these ancient records. From my perspective, this is the end of the road for Judeo-Christian theology. When you are forced out of the box, you must consider the legends of other cultures, especially when you find the same myths. Babylonian cuneiforms, the *Holy Bible*, the *Dead Sea Scrolls*, the great Vedic works, the *Mahabharata* and the *Ramayana*, and the epic Greek myths all contain stories about angels or gods dividing the Earth and then fighting a war in the sky over the possession of disputed lands and the control of mankind.

Here is where the chasm opens wide and you must make that leap of faith. You can simply accept these writings in symbolic terms, or at least try to place this unusual aspect of history into a realm already known to be possible. Space flight is a reality and where it will one day lead no expert can even begin to hypothesize. Science and technology have always challenged the impossible, and they continue to evolve toward places unimagined.

Zecharia Sitchin has also long supported the theory of extraterrestrial colonization of both the Earth and Mars. As a noted biblical scholar with the ability to translate many ancient texts, including Sumerian cuneiforms, his series of books entitled *The Earth Chronicles* contends that the creation myths in *Genesis* are not only derived from the tales of the much older Sumerian and Mesopotamian civilizations, but Sitchin also claims that extraterrestrials created those civilizations around 450,000 BCE.

In his first book, *The 12th Planet*, which was published in 1976, he translates the Babylonian words Annunnaki as "Those of Heaven Who Are on Earth" and IGI.GI, as "Those Who See and Observe."

Babylonian Epic of Creation (Zecharia Sitchin)

Assigned to Anu, to heed his instructions,
Three hundred in the heavens he stationed as a guard;
The ways of Earth to define from the Heaven;
And on Earth,
Six hundred he made reside.
After he all their instructions had ordered,
To the Annunnaki of Heaven and of Earth
He allotted their assignments.

If you place this text alongside verses from the *Book of Enoch*, Zitchin suggests that there were six hundred Annunnaki that colonized the Earth, while three hundred beings known as IGI.GI monitored the colonists from orbit. Did two hundred of the IGI.GI mutiny? As I have explained, Hebrew scholars had access to Babylonian libraries, so was the *Book of Enoch* influenced by ancient Sumerian myths? Zitchin has discovered more corroborating myths that can be found in the Hittite and Hurrian writings known as the

Kingship of Heaven Tablets. In these tales gods known as the Irsirra are translated as "Those Who See and Orbit." He also found that the Egyptians used the word NTR (Neter), which means "One Who Watches" or "Watchers", to describe their gods. 9


The idea of extraterrestrial intervention in human history is laughed at even harder than the myths of Atlantis, but the evidence suggests that somewhere between the two mysteries lies the answer to Earth's past. We may not care for those answers, for if we stick to the historical literature, there are grave implications for the future.

Though it might be a matter of interpretation as to their appearance in any religious scripture or in the prophecies of Nostradamus, extraterrestrial beings and UFOs do appear quite frequently in works of art extending back millennia. This active participation in humanity's past begs the question, what is their participation in our world today?







Slipping deeper into the conspiratorial cannot be helped. So, we must also include into any debate about ancient astronauts or antediluvian kingdoms the current phenomena of Unidentified Flying Objects. Sixty years of intense manipulation and marginalization have made this subject easy to laugh at, much to the delight of all the skeptics. But after more than a half-a-century, UFOs have, in fact, become modern lore. The credibility of some witnesses is beyond question and that simple reality points back toward the historical reality.

Few published researchers on prophecy have made the connections to this the most important aspect of Real History and the Real World. The reality of UFOs and extraterrestrials has grave implications when you look back on world mythology and then compare these myths with passages in the book of *Revelation* and to the prophecies of Nostradamus and Edgar Cayce.

Addressing the mountain of evidence about the reality of UFOs is beyond the scope of this book, but a true mystery exists. The heart of this mystery will be how all of us come to terms with what we define as good and evil.

There is a long history of disinformation that has been presented by government officials around the world on the validity of extraterrestrial visitations to Earth. It has generated a wide range of speculation about the nature of the UFO, alien-abduction, cropcircle, and cattle-mutilation phenomena, all of which seem to be wound tightly together in some, as yet, inexplicable way.

For nearly fifty years there have been an amazing amount of photographs that are simply too hard to dismiss. However, since the advent of Hollywood special effects and personal computers capable of video and photographic manipulation, society seems to have been sufficiently desensitized. Now all photographic and video evidence can be easily dismissed as an Internet hoax. The famous pictures below precede affordable computer imaging software, but nonetheless, each has been controversial.





The deception involved concerning UFOs is deeply institutional. It seems to be imposed on most world governments from a powerful multinational group that has circulated within the Western military-industrial complex since the end of World War II.

Richard C. Hoagland and researchers at the Enterprise Mission certainly have documented NASA's ritualistic behavior when acquiring launch windows for space missions. Each launch seems to be linked to the altitudinal positions of the stars Sirius, Regulus, and the belt stars of Orion. Clearly, the tampering of photographic evidence from both the Mars Global Surveyor and the Mars Express missions indicates that the United States Jet Propulsion Laboratory and the European Space Agency have the same agenda of secrecy concerning any life or past civilization existing on Mars. Since most of the Western powers have mutual defense treaties, this would be expected.

Occasionally, there seem to be tantalizing and well-placed leaks from different government agencies involving UFOs or data from the Martian probes. Some people suggest that this is meant to force humanity to exercise its collective mind by accepting a larger universe over the slow course of time. Other people believe that it is meant to lead us away from the truth and to train the average person to be ardently incredulous to anything that sounds remotely conspiratorial.

Until recently, I had wrestled with this question for quite a long while. Over the years, a general excuse I had accepted about the conspiracy of denial was that perhaps government officials, who are unable to understand the phenomena or do anything about it, have had to use intimidation to keep their impotence a secret from what would be an alarmed world.

Even though many individuals and small groups of people seem to have dream-like, ethereal experiences, governments around the world have clearly been forced to respond to the physicality of the UFO phenomena. Unfortunately, in this regard one disturbing fact has always emerged; the mystery becomes more mysterious because it has been exploited to the fullest by entities within the intelligence and military services. This has been very well documented in *Out There*, by journalist Howard Blum and by the respected scientist and astronomer, Dr. Jacques Vallee in his book *Revelations, Alien Contact and Human Deception*.

A book devoted to one specific operation, *Project Beta* by Greg Bishop, reports how Dr. Paul Bennewitz, a physicist investigating UFOs, was driven to a nervous breakdown by United States' Air Force intelligence operatives. This story is also covered in Howard Blum's, *Out There*. Unsuspecting people have been chosen as laboratory rats for psychological warfare experiments by the military and Central Intelligence Agency of the United States. The CIA's Project MKULTRA seems to have a relationship with the UFO phenomena, and Linda Moulton Howe is currently presenting copies of documents from the files of the late James Jesus Angleton, the famous CIA Chief of Counter-intelligence, that ties UFOs to Project MKULTRA and Project ARTICHOKE. 11

The entire paranormal field finds some very interesting connections to military and political organizations throughout the world. Lynn Picknett and Clive Prince outline some of this secret web in their book, *The Stargate Conspiracy*. There are many authors and researchers interested in UFOs and ancient civilizations with less than six degrees of separation from government intelligence agencies and leading research institutions. All of

this, therefore, becomes a conspiratorial delight to those who love a mystery, or a night-mare to those who are already paranoid.

The report of a crashed flying disk near Roswell, New Mexico on July 7th, 1947 has now become a modern myth. However, as many of the participants in the alleged event get older, the testimony they are leaving as their legacies seems to be making the story more of a historical fact. Lt. General, Phillip Corso claimed to have been the military liaison that steered extraterrestrial technology to private industry for development. Before he passed away, Mr. Corso felt compelled to put the details of what he knew into a best-selling book, *The Day After Roswell*.

Mr. Corso and I shared one degree of separation, and I can tell you from second hand sources that he was consumed with the subject. It may not be allowed in a court of law, but that fact alone makes it hard for me to believe that he was a disinformation agent working well into his eighties. His experiences have heavily influenced his family, and that is a startling testimony to its reality.

Dr. Steven Greer, M.D. organized the CSETI Institute to gather sworn depositions from many government and military people that have witnessed or been involved with UFOs. ¹² Backed with evidence and testimony given to him by astronauts, military and commercial pilots, engineers and technicians, he has given briefings to United States congressmen, senators, and even high-ranking members within the Central Intelligence Agency. He presents these testimonies in his book *The Disclosure Project*.

The reality of extraterrestrial civilizations is so secret and compartmentalized that even intelligence, military, and government leaders are kept in the dark. Dr. Greer has stated that he was to meet with former Director of the CIA, William Colby. Colby was going to provide Dr. Greer with some extraordinary evidence on the realities of these extraterrestrial civilizations. The day before their meeting, Colby disappeared and was later found floating in the Potomac River, apparently having drowned while canoeing.

This is the nature of the beast. As I mentioned in the Introduction, it was clearly outlined for me by the sixth man to walk on the Moon. At that banquet of former astronauts on May 22nd, 2004, Dr. Edgar Mitchell told all of us at that table that he loses sleep at night over the thought that tremendous powers are being wielded to control individual freedoms using extraterrestrial technology. Apparently, our society has managed to minimize the opinions of one of the world's greatest explorers, as neither the reporter nor his editor, whose article in the St. Petersburg Times inspired this conversation, followed up on what has to be history's greatest single story. Certainly, it was worthy of a multipart series; it might have even helped newspaper sales.

Reportedly, a spaceship landed. It was all hushed up. I called Curtis LeMay and I said, 'General, I know we have a room at Wright-Patterson where you put all this secret stuff. Could I go in there?' I've never heard General LeMay get mad, but he got madder than hell at me, cussed me out, and said, 'Don't ever ask me that question again!'

The weight of the phenomena and the testimony of many good and sane people points to a reality all of us should begin to consider. I suggest to every reader that your gauge to measure coming world events must always be your individual freedom and how much of it you are allowed to retain. It is the beast in *Revelation* 13:17 that demands absolute control. He will gain that control through another beast that performs miracles.

Revelation 13:13 (King James)

And he doeth great wonders, so that he maketh fire come down from heaven in the sight of men.

Revelation 13:14 (King James)

And deceiveth them that dwell on the earth by the means of those miracles which he had power to do in the sight of the beast...

Whether the Watchers were, or UFOs are fully corporeal remains a subject of the debate. If the United States is developing extraterrestrial technology, than clearly, there is physical interaction with physical beings. However, this is the essence of the greatest mystery of all time. In our quantum, non-local universe, do we primitives really understand the nature of physical reality or perhaps spiritual reality?

Many accounts of the alien-abduction phenomena sound so surreal that many scientists are calling it a classic case of sleep paralysis. But you will find a very ancient account of an alien-abduction in one the apocryphal texts.

Testament of the Twelve Patriarchs Reuben 5

Thus they (women) allured the Watchers before the flood, for as these continually beheld them, they lusted after them and conceived the act in their mind; for they changed themselves unto the shape of men and appeared to them when they were with their husbands; and the women, lusting in their minds after their forms, gave birth to giants, for the Watchers appeared to them as reaching up to heaven.

Testament of the Twelve Patriarchs Naphtali 3:5

The Watchers changed the order of their nature.

The ability to change appearance is not only a science fiction staple, but also part of today's mythos concerning UFOs and alien-abductions. This includes the appearance of human-alien hybrid children, the first of whom seems to have been Enoch's great-grandson, Noah.

She became pregnant by him, and brought forth a child, the flesh of which was white as snow, and red as a rose; the hair whose head was white like wool, and long; and whose eyes were beautiful. When he opened them, he illuminated all the house, like the sun; the whole house abound with light.

As I have stated in the previous chapter, the etymological root for deva means shining. There are many references to shining beings in various mythologies. Artistically, Christian deities have often been portrayed as being surrounded by a nimbus. Also, the Nordic aliens, who are usually described with long blond hair, have been a part of UFO lore for over fifty years.

In another ancient Hebraic text, Lamech recounts his fears about his son's parentage. The *Genesis Apocryphon* was among the first seven of the *Dead Sea Scrolls* discovered at Qumran when a Bedouin shepherd tossed a rock into a cave and heard a clay vessel break. Is it just one of those historical coincidences that this happened in 1947 – the very same year of the crash of a flying saucer at Roswell, and also the same year that saw the beginning of the rebirth of Israel, a country that seems to be intimately connected with the Watchers? As you will read in Book Three, the angle a circumscribed interlaced tetrahedron makes to its surrounding circle lies at 19 degrees 47 minutes above and below the equatorial diameter of that circle. The Star of David is a two-dimensional representation of an interlaced tetrahedron. These numbers and this relationship seem to be an important clue toward deciphering a very ancient mystery.

It has become stereotypical to suggest that an extraterrestrial civilization genetically engineered humankind to be used as a labor force in their attempt to colonize the Earth, but over two thousand years of literary evidence certainly supports the theory.

Besides the proposition that the Watchers and Annunnaki are extraterrestrial in nature, there is also the possibility that an ancient, space faring civilization that once existed on both Mars and Earth was destroyed in a cataclysmic event that affected the entire Solar System. Perhaps the surviving Martians were able to recover after a few generations and then returned to Earth to find that the descendants of their counterparts had regressed into a primitive, tribal culture.

In either scenario, it seems that the sons of the gods began to school the indigenous population of Earth to build settlements and cities. Enoch, the seventh generation born from Adam, seems to have been the first student.

For such a pivotal character in human and angelic affairs, Enoch only gets a brief mention in the *Holy Bible*. There are actually three books known as the *Book of Enoch*.

Twenty-nine Ethiopic versions of *I Enoch* have been found to date and these closely match the Aramaic and Hebrew fragments found with the *Dead Sea Scrolls*.

II Enoch is the Slavonic Book of Enoch also known as the Book of the Secrets of Enoch. It was translated from Greek texts around the 7th Century and is a close account of the first book with additional chapters probably included from 1st century Hebrew documents. Only two versions of this book have ever been found, one in Serbia and the other in Russia.

III Enoch, also called the Hebrew Book of Enoch or the Apocalypse of Enoch, can be traced back to 200 CE. This version recounts the story of the last High Priest of the Temple of Jerusalem, Rabbi Ishmael, as he journeyed to heaven in a celestial chariot to meet the archangel Metatron, who was once known as Enoch. (Metatron is also referred to in the Old Testament in Proverbs 22:6 and in Job 32:6, as well as the Zohar I: 223b).

Enoch is history's first prophet of record, and if the texts that recount his life are correct, he is still alive this very day.

Book of Jubilees 4:19 (R.H. Charles)

And what was and what will be he saw in a vision of his sleep, as it will happen to the children of men throughout their generations until the day of judgment, he saw and understood everything, and wrote his testimony, and placed the testimony on earth for all the children of men and for their generations.

And he was moreover with the angels of God these six jubilees of years, and they showed him everything which is on earth and in the heavens, the rule of the sun, and he wrote down everything.

Book of Enoch I:2 (Richard Laurence Translation)

From them I heard all things, and I understood what I saw; that which will not take place in this generation which is to succeed at a distant period, on account of the elect.

The Jubilee is a period of forty-nine years, and it was celebrated at the conclusion of the forty-ninth year. This made Enoch's stay with the angels three hundred years. Could such a time span be due to Einstein's relativistic effects if celestial chariots traveled anywhere near the speed of light?

As I have mentioned, the Elect is a central character in the *Book of Enoch*, and the ultimate fate of the Watchers resides with his judgment. The Elect has been appointed by the Ancient of Days to preside over the final judgment. The messianic overtones are obvious and this is part of a great controversy because this text and the themes of a "pierced" messiah recounted in the *Dead Sea Scroll* fragment known as the *War Rule* predate Jesus Christ by nearly two centuries. So, the *Book of Enoch* may fill in some of the important details to the book of *Revelation* and the Second Coming.

In the last two centuries, the *Book of Enoch* seems to have been used to support a variety of metaphysical and occult belief systems, so the true importance of it as a historical record has been overshadowed by superstition. Perhaps this potential to misinterpret the book was the point of contention for the Church Fathers during the 3rd and 4th centuries. In the *City of God*, St. Augustine claimed that the book was too old to be included in the canon.

When Rome instituted the new state religion of Christianity, it adopted the same political tactics that the Caesars introduced; all heresies that threatened stability were eradicated. The fledging sects within the Christian religion were consolidated by the might of a decaying empire. Doctrinal issues and the shaping of religious and political thought by some of the Fathers of the Church is an important aspect to the spiritual evolution of Western civilization. Ostensibly, if extraterrestrials have been entwined with religious belief systems throughout history, then what is the nature of this entanglement? The growing diversity of opposing religious doctrines over seven millennia has induced wars, jihads and crusades. Are different powers at work; all vying for control of human belief systems all the while keeping the vast majority of humankind in the dark about the origins of those beliefs?

Always keep *Daniel* 4:17 in mind. If the Holy Ones of Heaven and the Watchers have the powers to choose kings than they also have the power to choose religious leaders. The Gnostic Christians believed that the Archons exploited religion. And clearly in the *Book of Enoch*, the two hundred Watchers are accused of setting themselves up as gods among the sons and daughters of men in opposition to the will of heaven.

Hebrew scribes were able to identify humanity's chief antagonists; in the *Book of Enoch* you will find two lists of names. These are the leaders of the rebelling Watchers. These lists are similar but not exact; both verses are an apparent seam in the book's long life. Depending on the list in verse VII:9 or verse LXVIII:2, these names can be found in familiar variations in the languages of many cultures throughout the Middle East and Asia. From these names we can derive the modern names of many well-known demons as well as that most infamous entity known to humanity, the devil.

Book of Enoch VII:9 (Richard Laurence Translation)

These were the names of their chiefs... These were the prefects of the two hundred angels, and the remainder were all with them...

Book of Enoch LXVIII:2 (Richard Laurence Translation)

Behold the names of those angels. These are their names. The first of them is Samyaza; the second, Arstikapha: the third, Armen; the fourth, Kakabael; the fifth, Turel; the sixth, Rumyel; the seventh, Danyal; the eighth, Kael; the ninth, Barakel; the tenth, Azazel; the eleventh, Armers; the twelfth, Bataryal; the thirteenth, Basael; the fourteenth, Ananel; the fifteenth, Turyal; the sixteenth, Simapiseel; the seventeenth, Yetarel; the

eighteenth, Tumael; the nineteenth, Tarel, the twentieth, Rumel, the twenty-first, Azazyel.

This verse is the more important, and probably the older of the two. The mentioning of Azazyel is notable, because the name is found across many cultures in one form or another. It is generally assumed that Lucifer is the leader of the rebelling angels, however, in the *Book of Enoch* the leader, Samyaza, seems to take on a lesser role while Azazyel, who is just one of the "Chiefs of Ten", becomes the personification of evil.

There are some researchers that believe Samyaza and Azazyel are the same being. Samyaza also appears as Shemyazaz. *Shem* is Hebrew for name and *azaz* can mean arrogance or rebellion, which could indicate that both words were combined at some point in history. The ground here is muddy because of the two lists of names and the following verse that competes with the description of Azazyel's crimes. Unfortunately, this is the nature of deciphering texts that have undergone over two thousand year of translations.

Book of Enoch LXVIII:6 (Richard Laurence Translation)

... Gadrel: he discovered every stroke of death to the children of men.

Book of Enoch LXVIII:7 (Richard Laurence Translation)

He seduced Eve; and discovered to the children of men the instruments of death, the coat of mail, the shield, and the sword for slaughter; every instrument of death to the children of men.

In *Enoch* VIII:1 we read that it was Azazyel that taught mankind how to make weapons. This name comes closer to the historical development that associates the devil with certain symbols now found in western culture.

Book of Enoch VIII:1 (Richard Laurence Translation)

Moreover Azazyel taught men to make swords, knives, shields, breast-plates, the fabrication of mirrors, and the workmanship of bracelets and ornaments, the use of paint, the beautifying of the eyebrows, the use of stones of every valuable and select kind, and all sorts of dyes, so that the world became altered.

During the 19th century, European explorers of Kurdistan described the Yezidi, a religious sect of the Kurdish people that is not related to Islam, as a religion of "devilworshippers." The Yezidi worshiped a group of angelic beings whose leader was Melek Taus, the Peacock Angel. After the fall of the angels, Melek Taus is said to have quenched the fires of hell by repenting and crying for seven thousand years. The Yezidis' holy book holds that the Peacock Angel was also known by another name, Azazil. Coincidentally, the name Lasifarus also happens to appear in their pantheon of angels. ¹⁴


Lucifer is derived from the two Latin words *lux fere*, which means light-bearer. The Greek translation of the Hebrew, "the brilliant one" and "son of the morning," was associated in the *Septuagint* with the myth of heosphoros, the Dawn-Bringer. Thus Lucifer is also known as the "Morning Star."

It is also an interesting correlation that Azazyel taught men to make weapons, taught women how to be more seductive, and taught humanity that stones of certain kinds had value. Violence, sex, and greed seem to be the hallmarks of our modern notions about sin and the devil.

As you will read in detail in the next several chapters, the Watchers were ultimately forced to retreat because of the Flood. The survivors then seem to have been systematically defeated in a series of battles using nuclear-like weapons that were deployed across the lands of modern day Israel, Iraq, Iran, and the northern parts of India and Pakistan

After the archangels had finally captured Azazyel, Raphael bound his hands and feet and then dug a hole in the desert. The rebelling angel was then buried and had a mountain placed over him so that he would remain in darkness until the Final Judgment. Azazyel's punishment is memorialized in the ritual followed on the Jewish Day of Atonement. Found in *Leviticus* 16:8, as well as in the *Dead Sea Scrolls*, every Yom Kippur two goats were to be chosen by lottery; one was to be sacrificed and one was to be released into the desert. "*This is for Azazyel*," was spoken as the scapegoat was sent to find its way into Dudael, the place of Azazyel's imprisonment.

The goat has long been symbolic of Satan, and his name is derived from the Hebrew word ha-satan, meaning "the adversary."

It is interesting that many world myths of demons imprisoned under mountains after a great battle in heaven resemble elements in current UFO lore concerning a vast network of underground extraterrestrial bases found in various locations around the world.

5 ...He will slaughter the he-goat which [has fallen to YHWH...]

He will wash his hands and his feet from the blood of the sin-offering and will go to the 11 live he-goat and will confess over its head all the sins of Israel with all their guilt together with their sins; he shall place them upon the head of the he-goat and will send it 13 to Azazel, to the desert...

Since this is a book on prophecy, than identifying the primary evil antagonists during the End of Days is of paramount importance. I think most people believe that this will be an easy affair, a case of black and white. Unfortunately, it all comes down to every individual's point-of-view, as the 19th century European explorers of Kurdistan and the long persecuted Yezidis came to understand. The belief that "my god is bigger than your god" has been universal and timeless.

As I will show in the following pages, the lines dividing a shared global myth have been blurred for over seven millennia, perhaps intentionally, and perhaps much longer if you accept the possibility of an antediluvian civilization. Over the long course of time, different cultures have adopted aspects of this myth in pursuit of some political or material gain. A general rule of thumb is: the larger the empire, the more powerful the god. Nearly every religion and every myth has mankind embroiled in the politics of various heavenly pantheons, and what is clear from these written records is that the gods tend to redistrict, looking for greater spheres of power and influence. For their constituents, however, this has never been a good thing, because holy wars have spilled great quantities of human blood.

The one frightening aspect and the one commonality many religions seem to share is this fascination with the idea of blood sacrifice and martyrdom.

There is a very long history of human sacrifice as well as warfare conducted in the name of a variety of gods. Violence seems to be the test of all spiritual beliefs. It is the darkest element of all religions that require it to make converts. In the course of history, human beings have taken other human beings and have had them bound and thrown into peat bogs, some have been skinned and had their hearts cut out, others have been thrown off of cliffs, and still others have been burned alive at the stake or have been torn apart on the rack. There seems to be no end to the inventive ways that people have been tortured and sacrificed in the name of some god. How do you compare the sacrifices made by an Aztec Priest who flayed his victims and cut out their hearts, to a Priest from the Inquisition who performed vivisections on his victims to illicit a confession or a belief in his version of god? It is quite certain that all of the victims had a clear understanding of good and evil. Humans rationalize and history decides good and evil.

It is more than interesting and coincidental that the use of torture is now openly employed and advocated by the United States government and by default those nations involved in the rendition of those prisoners that are tortured. As you will read in Part Two, this is essentially the Roman-Nazi method of control and directly related to Nostradamus' Pagan Cult. The motives of people who call for such suffering should always be called into question. After the Hebrews began sending their children to a fiery death in the furnace of Molech, they were conquered and enslaved.
